The original media is deleted immediately after processing; only derived text is retained for a short period for quality assurance. StudyBel is intended for private-study and research uses and is not a tool for distributing copyrighted works.

## 3. Eligibility and Accounts

You must be at least 13 years old (or the age of legal majority where you live) to create an account. You are responsible for all activity under your account. Keep your login credentials secure. If you use StudyBel on behalf of an organization, you represent that you have authority to bind that organization to these Terms.
